

MESSAGE FROM THE CHAIRMAN




Dear Friend,



GROUP COMPANIES

KAMACHI SPONGE & POWER CORPORATION LTD.

Our flagship company, Kamachi Sponge and Power Corporation Limited (KSPCL), is a fully integrated steel & power plant designed to manufacture clean steel with continuous backward and forward integration. It produces Kamachi TMT re-bars from continuous cast billets made from virgin iron ore. The steel making facility is spread across 60 hectares and is equipped with state-of-the-art German technology and facilities to offer steel of world class standards. The factory can be classified into 5 divisions which are run as individual profit centers and are yet, fully integrated to ensure peak performance and maintain the desired quality.

Our Zero Waste Disposal policy ensures all by-products generated are utilised completely.

DRI/SPONGE IRON DIVISION

120,000 MTPA of installed capacity with a configuration of 4x100 TPD kilns. This division can handle iron ore to pellets and maintains its own crushers to handle ore sizes upto 200mm.

STEEL MELTING DIVISION

205,000 MTPA of installed capacity of mild steel billets up to I2mtr x I60mm in size. With continuous casting and Liquid Refining Furnaces (LRF), alloy grade quality can be maintained.

ROLLING MILL DIVISION

500,000 MPTA installed capacity. State-of-the-art horizontal and vertical configuration German rolling mill and TMT technology from Thermex to produce world class re-bars ranging from 8mm to 52mm in size with customised lengths.

10MW POWER DIVISION

This innovative project generates I0MW of power from excess heat recovered from sponge iron Kilns, thereby controlling emissions as per international standards and reducing our Carbon footprint. This project is also registered for Carbon Credit.

70MW POWER DIVISION

Meets the captive power requirement of the entire plant.

Surplus power is exported to TNEB & third parties. Latest

CFBC boilers ensure maximum efficiency and maintains its

own 230KV switch yard to reduce transmission losses.

KAMACHI STEELS LTD.

Incorporated in 1995, it is an integrated plant with multi-location steel processing. It manufactures billets via the continuous concast route and rolls re-bars with Thermex technology to ensure consistent quality. Together, the installed capacity is 180,000 MPTA and the company also maintains its own stockyard of above 1,50,000 sq.ft.

The company meets its partial power requirements through its wind energy investments.

GOYAL ISPAT LTD.

Goyal Ispat Ltd. was taken over as a sick company by Kamachi Group in 2001. Under the able leadership of Mr. Ghisulal Kothari the company had a turnaround, cleared all its accumulated losses and is now a profit making company. The company engages in rolling re-bars with Thermex technology and also engages in iron & steel trading. With an installed capacity of 75,000 MTPA, it produces the well-known Kothari TMT Ribbed Bar, like Kamachi Steels Ltd. The product is of superior quality and has an established market presence. It also holds the distinction of being a pioneer in registering Tamil Nadu's first TMT brand.

MAA DURGA ENTERPRISES LTD.




KAMACHI GRANITES PVT. LTD.


